

Payment Methods

The Millennial Hostels accepts Visa, MasterCard, American Express, select Debit Cards, UPI, and Net Banking. Other payment methods may be added from time to time.

Order Confirmation

If you do not receive a confirmation number (in the form of a confirmation page or email) after submitting payment information, or if you experience an error message or service interruption after submitting payment information, it is your responsibility to confirm the same form your booking history whether or not your order has been placed. Only you may be aware of any problems that may occur during the purchase process. The Millennial Hostels will not be responsible for losses (monetary or otherwise) if you assume that an order was not placed because you failed to receive confirmation.

Refunds and Exchanges

Acceptance of Terms

- Through the Website, The Millennial Hostels shall provide you (User) hostel-related information, and availability for all its services across Bangalore City, as more particularly described and defined in the Terms of Service ("TOS") relating to such service, this service may be availed by the user, his/her family members, and friends in India and Abroad at any time during the year.
- This user agreement sets out the Terms and Conditions on which The Millennial Hostels shall provide the Services to the User through the Website. In addition to this Agreement and depending on the Services opted for by the User, the User shall be required to read and accept the relevant TOS for such Service, which may be updated or modified by The Millennial Hostels from time to time. Such TOS shall be deemed to be a part of this Agreement and in the event

Severability

Termination of Agreement and Services

- Either the User or The Millennial Hostels may terminate this Agreement and a Service with or without cause at any time to be effective immediately.
- The User agrees that The Millennial Hostels may under certain circumstances and without prior notice, immediately terminate the User's user id and access to the Website/Services.
